

As the third week comes to an end, some committees are quickly approaching their last scheduled meeting. A few bills started moving through the committee process this week, which means they will stay in play for a few more weeks. Many of these bills will die in the committee process unless amended with a bill that's moving.

Two of our priority bills are continuing to move in the Senate but have not yet moved in the House. We will continue to meet with the Committee Chairs to move these bills.

The initial budget for the House is \$89.9 billion for the 2019-2020 fiscal year. The Senate has a proposed budget of \$90.3 billion, which has the two chambers \$400 million apart; the Senate's budget includes about \$1.8 billion for Hurricane Michael relief.

Last year, the Legislature passed, and then-Governor Rick Scott signed into law, an \$88.7 billion budget. Governor Ron DeSantis has recommended a proposed budget totaling \$91.3 billion.

Hurricane Michael came ashore as a Category 4 hurricane with winds in excess of 155 mph causing widespread damage to the community and many of our members' own homes. The IAFF and FPF were there on the ground just after the winds subsided to provide aid and it's good to see that the State is stepping up at this level to assist in the rebuilding.

I'm confident this budget will address the needs of this part of the State to continue the rebuilding process. CFO Patronis has been working with the Governor and the legislature to address the needs of the community and the increased wild fire hazard due to all the downed trees. These trees may not receive proper cleanup without some financial assistance.

Funding for Firefighter Cancer Research is still in play with a possible appropriation of one million. We will continue to track these research funds for the Sylvester Comprehensive Cancer Center. We were honored to participate in the filming of documentation videos to reduce firefighters' exposure to carcinogens.

These videos were a result of partnering with the Sylvester Comprehensive Cancer Center, the Florida Firefighters Safety and Health Collaborative, Chief Tucker, Melvin Stone and the staff

at the college. The videos will be used as a statewide educational tool for existing personnel and new firefighters in the fight to reduce firefighter cancer. I would be remiss if I didn't thank the many departments that sent an engine and crew for the filming: Orange County, Gainesville, Jacksonville, Lakeland, Palm Beach County, Marion County, and Kissimmee.

A late Proposed Committee Bill (PCB), SB 2504, has been filed to move the state employee collective bargaining impasse resolution through the appropriations process. We will watch this bill and the inevitable House bill that will work its way through the budget process.

In addition to Vice President Rocco Salvatori and Secretary/Treasurer Gilbert Marsh, we had Palm Beach Local 2928 President Scott Bielecky and Angelo D'Ariano, Metro-Dade Local 1403 President Omar Blanco and Rich Andrews, and Andre Cruzeta in Tallahassee; all their assistance is greatly appreciated.
